CRISP HIE Services for Ambulatory Practices

Connect. Share. Improve Patient Care

CRISP is a regional health information exchange (HIE) serving Maryland, the District of Columbia, and West Virginia. We also exchange data regionally with provider organizations in Delaware and Northern Virginia. We are a not-for-profit organization advised by a wide range of stakeholders who are responsible for healthcare throughout the region. CRISP has been formally designated as Maryland's statewide health information exchange by the Maryland Health Care Commission.

Clinical Query Portal

The CRISP clinical query portal is a free, web based tool to access your patient's clinical data through the HIE.

- CRISP receives clinical and encounter data from over 100 hospitals in MD, DC, WV, VA and DE, including all 55 acute care and critical access hospitals in Maryland and DC.
- Physicians, licensed health providers, care coordinators, and support staff can have access to query patients they are treating, or have a care coordination relationship with and view clinical data.
- Access patient demographics, lab results, radiology reports, Maryland Prescription Drug Monitoring (PDMP), discharge summaries, history and physicals, operative notes, and consults.

Encounter Notification Service (ENS)

ENS allows primary care physicians, care coordinators, and others responsible for patient care to receive real-time alerts when their patients are seen in the ED or admitted or discharged from the hospital, long-term care facility or other participating provider organizations. These alerts will help your practice coordinate your patients' care and schedule any necessary follow-up treatments or visits. More than 700 ambulatory practices and practice consortia receive notifications from more than 100 acute care and critical care hospitals and over 90 long-term care facilities in the region.

Prescription Drug Monitoring Program (PDMP)

The Maryland Prescription Drug Monitoring Program gives you access to prescription information for all Schedule II-V drugs filled in Maryland and Virginia.

- Available inside Clinical Query Portal or through our new standalone PDMP portal.
- Prescribers, Dispensers, & other Licensed Staff may have access.
- View interstate PDMP data for neighboring states.
