Vaccine Tracking Tool Timothy Hoye, Client Manager at hMetrix



Tool to help Practices track their patient population to ensure patients get COVID vaccine

Patient Navigator: Identify patients who have not been vaccinated and track patient outreach efforts

- Save user editable outreach status flag and free text notes
- Allow practices to focus outreach efforts on patients who have not been vaccinated and are at high risk

Reporting: View Summary Reports tracking vaccination progress over time and compare to relevant peer groups


Vaccination data updated daily from State Immunization Information System (IIS)



CRISP can now apply logic, using various data sources, to limit/target ENS alerting, enabling more actionable, useful notifications.

Examples

- Death Notification CRISP receives MD Vital Records data and can generate ENS alert listing those patients attributed to a provider who are deceased. Data lag can be up to 2 weeks. (PROMPT filter and/or daily .csv summary file)
- Low-Acuity Non-Emergency ED Visit ENS Alerts If a patient presents to the ED with a low-acuity, non-emergent diagnosis, an ENS alert can be generated (PROMPT filter and/or daily .csv summary file)
