Upcoming CTI Releases



CTI Year 3

- Year 3 of the CTI will begin on July 1, 2023.
 - Hospital can keep, drop, or modify CTI for the upcoming performance year.
 - The CTI Application Process will open on April 4, 2023, and close on May 31.
- Existing CTIs will be automatically carried over to the new performance year.
 - Hospitals DO NOT need to do anything to maintain their existing CTI definitions.
 - To add a new CTI, Hospitals will need to use the Care Transformation Profiler.
 - To drop an existing CTI, hospitals will need to email <u>hscrc.care-transformation@maryland.gov</u>.

Final CTI Results

- Final CTI results for Year 1 (July 2021 June 2022) will be released at the end of April.
 - Results are mostly complete, and hospitals will be able to get a good estimate of their net savings after the next CRISP update on March 31.
 - Hospitals will CTI with a duration of 180 days have 1 more month of runout before they are complete.
- These MPA adjustments will be added to the MPA adjustment effective July 1, 2023.
 - The HSCRC will distribute a file with the MPA adjustments for each hospital in early May.
 - Note: Systems that are participating in joint CTI (including more than 1 hospital) will have to decide how to allocate their savings between the component hospitals.
 - There will be a short turn around for hospitals to decide (two weeks) so that we can make the adjustments in the MPA.
 - HSCRC will default to assigning joint CTI savings based on the hospital's Medicare revenue share.



New CTI Thematic Area

- Hospitals may propose new CTI Thematic Areas or new selection factors for existing CTI Thematic Areas.
 - If interested, Hospitals should reach out to <u>hscrc.care-transformation@maryland.gov</u> for an intake interview.
 - Additional CTI Thematic Areas will be available for the year starting in July 2024.

Reporting Enhancements



Reporting Enhancements

- The next CRISP update will include the enhancements to the reporting tool.
- Panel-Based CTI Reports
 - Previously, the CTI Reports were not particularly useful for panel-based CTI.
 - We have added a monthly PMPM comparison to the CTI Reports.
- More detail on the construction of the target prices
 - We added a breakdown of the target prices.
 - Note: This will be updated monthly so that participants can track the change in their risk month on a month over month basis.
- Update to the State Summary Tab
 - We revised the State summary tab to calculate the statewide offset correctly.
 - Previously, the offset netted all costs / losses from all CTI. The new report only sums the positive savings earned by hospitals.
 - There will still be an issue the minimum savings rate.
- Adding a Final Reconciliation
 - We added a tab that shows the final reconciliation.
 - This will show the "waterfall" of savings.


Mean Episode Payment


Cumulative Spend


Statewide Performance Update
