

## **CRISP Reporting Services Publication Dates – 2024**

Below are the 2023 publication dates for the CRISP Reporting Services (CRS) portal (report.crisphealth.org). The CRS team will refresh reports with updated data on the dates listed below. These dates are subject to change due to any data delay or data quality issue.

TABLE 1: Data for these reports are released around the first full week of the month

- All Payer MD Hospital Case Mix Reports Maryland hospitals are required to submit preliminary all-payer hospital Case mix claims to the Health Service Cost Review Commission (HSCRC) fifteen days after the end of a month and sixty days after the end of a quarter. All HSCRC regulatory reports rely on Final data for official scorekeeping, however, are continuously updated with preliminary data to assist hospitals trend results. Other reports using this include Patient Total Hospitalizations (PaTH), Pre/Post Reports, Care Coordination Reports, Readmission Tableau Reports, Public Health Dashboard, and the Avoidable Admission Report
- Medicare CCLF Data Reports The Maryland Primary Care Program Reports (MDPCP), CCLF Medicare Analytics & Data Engine (MADE), Medicare Performance Adjustment (MPA) Monitoring Reports are generated using CMS's Claim and Claim Line Feed (CCLF) data with the latest month of CCLF data indicated below.

\*Please Note - The date range of included CCLF data in MADE varies by reporting module. For details on the data available for each module, please refer to section 2 of the MADE FAQ document in the Help section of MADE.

TABLE 2: Episode Data for these reports are released around the middle of each month

- **Care Redesign/Care Transformation Reports** There are two primary reports supporting the Care Redesign/Transformation programs:
  - Care Redesign Program (CRP) Management Interface The CRP Management Interface allows users to view current and past Quarterly CRP Reports, care partner certification / vetting lists, and implementation protocols. Currently implemented only for ECIP.
  - Care Transformation Profiler (CTP) The Care Transformation Profiler provides aggregate data on all active Care Transformation Initiatives that have been approved by the HSCRC, as well as CTI definition summaries and, for users with PHI access at their facility, a link to the MADE Population Navigator to view additional beneficiary level detail.
