## Enhancing Advance Care Planning with CRISP

With the support of the Maryland Department of Health, CRISP is building a new infrastructure to simplify how ACP documents are consumed, managed, and displayed within the clinical workflow.

The session will begin with a brief introduction to the project (5 minutes), followed by an in-depth presentation from CRISP outlining the project goals, the technical integration process, and the benefits for providers.

Improving Access to Medication History: Non-CDS Medications

**Time:** 1:45 to 2:15 pm

**Description:** This session provides a comprehensive overview of the Maryland Health Care Commission (MHCC) and CRISP's collaborative efforts to improve access to comprehensive medication histories through the submission of non-controlled substance (non-CDS) dispense data. These efforts, in accordance with Maryland House Bill 1127, are crucial for supporting patient care coordination and improving clinical decision-making.

Maryland law mandates the submission of non-CDS dispense information to CRISP, which serves as the State-Designated Health Information Exchange (HIE). This initiative aims to improve patient care coordination by providing authorized individuals with access to comprehensive medication histories. Dispensers of non-CDS medications, including certain pharmacies and healthcare practitioners, will be required to report dispense information to CRISP starting in September 2025.

The session will highlight the steps dispensers need to take to begin reporting and how CRISP, in partnership with Leap Orbit, is streamlining the data collection and storage processes. Participants will gain insights into the technical, policy, and operational aspects of non-CDS reporting and learn how this data will be used to enhance clinical care.

What is and How to Talk with Patients About Sensitive Data

Effective communication is key to ensuring that patients feel informed, comfortable, and secure in making decisions about their data.

We'll start with a brief overview of the legal framework, types of sensitive data, and the implications of missing information without patient consent. We'll also introduce the CRISP Consent tool, designed to promote transparency and security. Guest speaker Meghan Reading Turchioe, PhD, MPH, RN, FAHA, will offer expert strategies for communicating the value of data sharing and building patient trust. Learn best practices to support informed, confident decisions about health data.
