



Prescriber Insights Report User Guide

Overview

The Prescriber Insights Report, available in the Prescriber Reports tile of the CRISP Portal, is a clinical tool for a prescriber's use and benefit to help them monitor their prescribing habits.

The data in this report is based on all of the controlled substance prescriptions that a prescriber has written that have been dispensed in or into Maryland and are only shared by CRISP to individual prescribers. By allowing providers to review their prescribing history, CRISP enables them to see how they are doing in comparison to their peers and provide confidence in how one is prescribing.

This educational report is intended to support prescribers in better understanding their prescribing habits and is available to PDMP-registered prescribers with individual DEAs through the CRISP Portal.

Accessing the Report

The Prescriber Insights Report is available in the Prescriber Reports tile of the Portal along with the Maryland PDMP at <https://portal.crisphealth.org/>.



The Prescriber Insights Report consists of two tools: Individual Prescriber Metrics and Prescriber Comparison. Individual Prescriber Metrics can be found at the top of the report, and Prescriber Comparison can be found at the bottom.

Individual Prescriber Metrics

At the top of the Prescriber Insights Report, users will see five metrics based on a 90-day lookback period from the date indicated.

When you hover over the blue circle icon, the following tool tips will appear under each category:

1. **MME**, an abbreviation for Morphine Milligram Equivalents, indicates the total number of patients who had at least one day with a dose of 90 or more MME based on all active prescriptions during the 90-day lookback period. You wrote at least one opioid prescription during this time period to a patient that contributed to the patient meeting the 90 or more MME threshold.
2. **Opioid Overlap(s)** indicates the total number of patients who had 3 or more days of overlapping opioid prescriptions during the 90-day lookback period. You wrote at least one opioid prescription to a patient during this time period that contributed to the patient meeting the overlapping opioid threshold.
3. **Benzo & Opioid** indicates the total number of patients who had 3 or more days of overlapping opioid and benzodiazepine prescriptions during the 90-day lookback period. You wrote at least one opioid or benzodiazepine prescription to a patient during this time period that contributed to the patient meeting the overlapping threshold.
4. **Multiple Provider** indicates the total number of patients who received controlled substance (CS) prescriptions from 5 or more prescribers and were dispensed CS medications from 5 or more pharmacies during the 90-day lookback period. You wrote at least one prescription to a patient during this time period that contributed to the patient meeting the multiple provider threshold.
5. **Long-Term Opioid Use** indicates patients who had greater than or equal to 60 days of consecutive opioid prescriptions during the 90-day lookback period. You wrote at least one prescription during this time period to that patient that contributed to the patient meeting the long-term opioid use threshold.

Upon clicking “Patient Details” the following view opens to display the name and date of birth for all patients who contributed to the respective metric unit.

To download the patient details, click on the ellipsis button (...) in the top right corner and select **Export data**. Choose **Summarized** data and then select CSV.

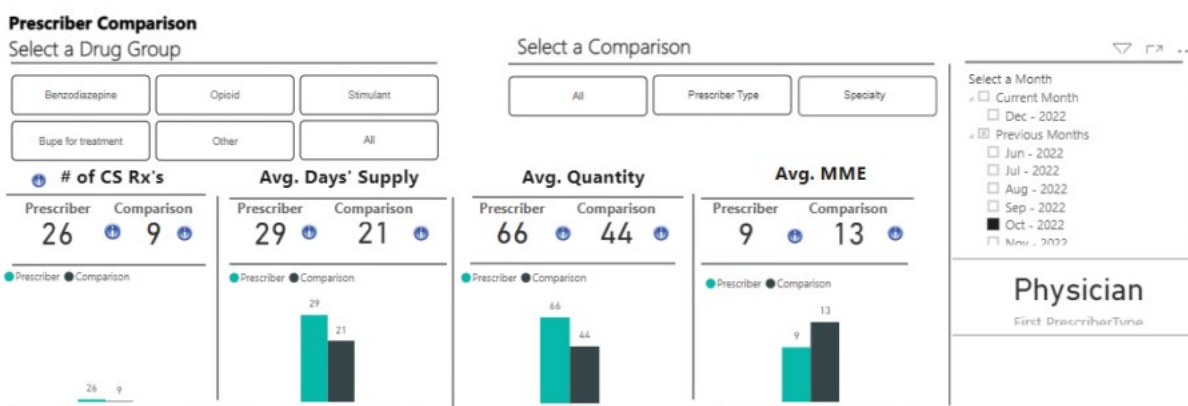

As indicated above, users can export the information displayed in patient details as a CSV file by clicking on the “...” button in the top right corner. To view more information about a specific patient’s prescriptions, search the PDMP for the patient to view their controlled substance prescriptions under the “Clinical Information” card in the CRISP Portal.

Prescriber Comparison

At the bottom of the report, users will find the Prescriber Comparison section. This tool allows prescribers to compare their prescription history to others.



To utilize the comparison section, users must select a month, Drug Group, and Comparison Group for the data.

- **Select a Month:** Note that only one month of data will display at a time. Users can choose a specific month to view from the dropdown list. Date is based on day the prescription was written.
- **Select a Drug Group:** Users may choose a specific drug group or combination of groups to view. Simply click on a drug group to include that group. The default includes all the drug groups. Users may select multiple groups at the same time. The ‘Opioid’ drug group excludes buprenorphine containing products that have an FDA indication for treatment of substance use disorder. The ‘Bup for Treatment’ only includes buprenorphine containing products that have an FDA indication for treatment of substance use disorder.
- **Select a Comparison:** Users may choose a specific comparison group or compare to all other Maryland prescribers.

Each graph contains the number attributed to the users on the top left and the number attributed to the chosen comparison group on the top right. There are two bars on each graph: the lighter green bar on the left indicates the user’s individual prescribing data, and



the darker green bar on the right indicates the average prescribing habits of the selected comparison group. Hover over the blue icons for a description of the specific metric.

The four metrics available in the Prescriber Comparison section are as follows:

- **# of CS Rx's** displays the total number of selected CS prescriptions written during the chosen month.
- **Avg. Days' Supply** displays the mean (average) days' supply for all selected CS prescriptions written during the chosen month.
- **Avg. Quantity** displays the mean (average) quantity of all selected CS prescriptions written in the chosen month. Quantity includes all forms of medications, including tablets, liquids, films, etc.
- **Avg. MME/Day** displays the mean (average) Morphine Milligrams Equivalents (MME)/day of opioids written the chosen month. MME only displays for opioids and excludes buprenorphine that has an FDA indication for treatment of substance use disorder. Click here for fact sheet on MME.
