

Electronic Health Care Transaction Reporting

- ▶ SB 748/HB 1022, *Public Health – State Designated Exchange – Clinical Information* passed during the 2021 legislative session
 - Requires electronic health networks (EHN) to provide electronic health care transactions to the State Designated Health Information Exchange (CRISP) for public health and clinical purposes
 - CRISP is required to develop and implement supporting policies and procedures for EHNs
- ▶ Aims of the law
 - Expand access to important clinical care information to inform treatment decisions and improve patient safety
 - Enhance statewide public health reporting capabilities
 - Foster innovative care delivery models through the use of claims data

Components of Technical Guidance



Components	Options for Specifications
Transaction types	Specs specific to each transaction
Patients that received services in Maryland	How to best define "in Maryland" <ul style="list-style-type: none">Rendering provider address? Billing provider address? Service location?
Submission format We will provide an option for flat file and standard transaction formats	Flat file: <ul style="list-style-type: none">File type (e.g., pipe delimited CSV)Content/variables; should these map to X12 loops/segments/data elements?Claims versioning, adjudication status?Other considerationsValue specifications Standard transaction: X12?
Cadence At least monthly	Define routine submission timeline <ul style="list-style-type: none">Ok to submit more frequently; real timeEHNs can be on different submission cadences

Components of Technical Guidance, *continued*



Additional Considerations	Options for Specifications
Data exchange format	CRISP can handle multiple options ranging for SFTP to FHIR <ul data-bbox="770 540 2506 610" style="list-style-type: none"><li data-bbox="770 540 2506 610">• EHNs can submit in different exchange formats
Originating EHN/Network Exchange	Should technical submission requirements consider transactions exchanged across multiple EHNs <ul data-bbox="770 720 2506 779" style="list-style-type: none"><li data-bbox="770 720 2506 779">• CRISP can de-dup after receipt
Testing Plans	Developed after issuing technical submission components
